





WICHITA.

HISTORICAL—Its Past, Present and Future.

Each year, as it glides around into eternity, leaves a history, unwritten though it may be, still it is a history, all the same. As time rolls around, and the years accumulate, scenes and incidents—at the time, of little consequence—in after years become important links in the great historical chain of a century gone. There are those here to-day who can look back and view the spot upon which now stands the beautiful and enterprising city of Wichita, as it reposes quietly in the lap of the rich and prosperous valley of the Arkansas, surrounded by forty miles of agricultural country, second to none other. It is even now, in these few short years of its existence, pleasant to trace back, minutely, the various changes that have occurred; the incidents that have taken place; and listen to the many tales which the early settlers were wont to beguile, the long and lonely hours of their tediousness. It would form a subject of absorbing interest, and the perusal of which would require many hours. But it is not our provience or purpose to relate the numerous reminniscences of the early settlers of Wichita, but rather to chronicle briefly that of a historical nature, leaving the "romantic" to those whose ability, augmented by experience, is much greater than our own

We find the following very full and complete history of Wichita in the Eagle of April 6th, 1876, which, by permission, we herewith give:

Just whose eyes were the first to behold this beautiful valley is something "no one can find out." J. R. Mead, years ago, established a ranche and trading-post on the White Water, at the present site of Towanda. Doc Llewellan lived on the Walnut futher on. Mead hunted buffalo where Wichita now stands, long before he ever dreamed of being a town proprietor, and Griffenstein camped and traded all around here for years and had no vision of the glories of Douglas Avenue. But hunters, traders, trappers and all whoever came along, were enchanted with the country about the mouth of the Little Arkansas, and all joined their voices to spread abroad its fame. During the drouth of 1860, everything, every where else, was parched and bare, there was plenty of good grass in the Arkansas

Valley, and stock was brought from the "settlements" to graze.

About the time of the close of the war, old man Chisholm began trading with the Indians up and down the river in the vicinity of where Wichita now stands, and built a ranche between the rivers on what is known as the "Abbott place," and near the present residence of J. C. Davis. In the year 1866 he moved over on to what is now known as Chisholm Creek, just north of the farm of John Ward, where he kept up trade until the winter of 1867. It is supposed that Old Chisholm was the first "merchant" in this part of the Valley, except Griffenstein, who had a ranche at "Cow Skin Grove," near the present site of the city of Jamesburg. Llewellan and Davis succeeded Chisholm in the mercatile business in the winter of '67. During that winter Durfee & Ledrick built an extensive ranche on the banks of the Little River, on the site of W. C. Woodman's beautiful "Lake Side." This ranche was a curiosity in its way and had more apartment than the palaces of the Magi, but its shadow, and perhaps its like, will be no more.

The primitive Grangers of the Arkansas Valley had red skins and no hay seed in their hair. Their principal crop, according to tradition was watermelons and greybacks; they raised a little corn, also. The first white farmer was Ledrich, who raised a crop in the season of '68, on what is known as the Griffenstein just north of town.

With the advent of Durfee & Ledrick's ranche came the first white woman to the valley-Mrs. Henry W. Vigus, and it is a faithful saying that a nobler woman never came. Vigus was a harness maker, and being well skilled in the art of distributing brass tacks and red flannel over a saddle and bridle, was a valuable man in the Indian trade, so Durfee, who well knew the Indian heart, secured Vigus to manufacture all their goods of that line. Vigus, shortly after his arrival, realizing the situation, built a hotel. It was worth a trip all the way to the Arkansas Valley just to see the hotel that Vigus built. It consisted of two stories, one above and one beneath the roof; but the beauty of the thing was the stairway, which went up on the outside. It was called the "Buckhorn," and its name and fame, like the horns, spread far and wide, and every man who ever stopped there will say, even unto this day, that Vigus kept a good hotel.

In May, '68, Ledrick withdrew, and Durfee took entire control of the ranche, and then came Milo Kellogg along and took charge of the business, and with him came Charlie Hunter, who soon after brought along his mother and sister. The little spot about the mouth of the Little River begun to be known as Wichita.

E. P. Waterman came and "took a claim" in February, '68, and D. S. Munger in the following May, and about this time Llewellan pulled up stakes and moved "over to town," and took a claim, and perhaps a dozen other families, among whom were Dunlap, Allison, Walker, the Meaghers and the Deckers, came and settled along the Chisholm Creek and the Little River.

During the summer of '68 a post office was established, and Milo Kellogg appointed postmaster, but no mail line was established to it, and the nearest "end of a mail route" was Towanda, and the mail was brought over by—whoever happened to bring it. It is supposed that Milo carried all the mail matter in his pants pockets, and everybody had a lock-box.

During that summer, also, Sedgwick county was attached to Butler for judicial purposes, and was constitured a township of that county for election purposes. D. S. Munger, being a man of influence at the capitol, was appointed Justice of the Peace. The records of his judicial proceedings have not come down to this generation, but living cotemporaries of his time tell us that he held well the reins of judicature, and was a just and unright judge, but unlike most judges of our day, he resigned the lucrative trust. The first law suit with which the valley was blessed, was tried in Judge Munger's court. It was tried at a time when the "Sedgwick County Bar" was yet in the raw. The case was entitled Alexander Jester vs. Charles Moore, and the cause of action was "tresspass and damage."

The first election was held in November, '68; being the presidential election both parties did their best, and thirty-five votes were polled. Inasmuch as Grant was triumphantly elected we suppose the vote of Sedgwick county was largely in his favor; but history is dumb on this point.

In the winter of '68 the first saloon was "opened." There was no free lunch on the occasion, but nevertheless the saloon survived. It is said there was no crooked whisky dealt out in that saloon, but it is a historical fact that the Little Arkansas was very low that winter.

During that winter a company of infantry were quartered at this point. Several of the boys having served out their time, were discharged and took claims. One or two married and are still with us, honored and useful citizens. One went to the mountains and his quietus made with his boots on. Another was chosen by unanimous vote, without even asking it, to represent Sedgwick county in the State Industrial Institute at Leavenworth, for a term of seven years. It was thought to be an act of justice by his constituents.

The spring of 1869 witnessed the advent of a great many new comers. A military road was opened from Fort Harker by way of Wichita to the military posts in the Indian Territory; Greenway came down from Marion Centre and opened a store; a ferry was established across the Arkansas river; there was a big cattle drive over the Chisholm trial; and money was plentier than it has ever been since, and things generally were "altitudelum."

In the fall of '69, Wm. Smith brought in a saw mill, and the manufacture of cottonwood lumber began. Soon after this followed the missionary, in the person of Dr. Boggs, a most excellent gentleman. He

organized a Sunday school which held its meetings in a large dug-out, just north of the city. Then came Rev. John Price Hilton and organized the Episcopal church.

In the month of October, 1869, an attempt was made to organize the county. A census roll was made and all other papers supposed to be necessary were made and forwarded to the Governor. It took a long time, in those days, for communications to reach Topeka and return, and the people not doubting that everything was lovely, and wishing to have all things ready, proceeded to put things in that shape vaguely designated "cut and dried." A convention was held and a ticket put into the field, and in due season an election held, and the "ticket" was triumphantly elected. The antiquarian in examining the tablets and parchments on which the accounts of these things were written, could only deciphe the names of two gentlemen who figured in that illustrious campaign. Col. D. M. V. Stuart was elected Sheriff, Vigus and Dunlap, Commissioners. About the time the last township was heard from a communication was received from the Governor stating that on account of the irregularity and informality of the papers he should be compelled to take the proper steps to organize Sedgwick county. There is indubitable evidence tending to show that Col. Stuart rested on his laurels in St. Louis that winter.

During the fall and winter of '69 immigration was brisk; Reuben Riggs came in and opened the first "law and land office." J. M. Steele and G. H. Smith also came and opened an office in the "Buckhorn" as the only authorized agents of the Great American Wire Fence Company—they did a very successful business. John Falkenstein and Dan Hoover came in and settled on Chisholm creek. The whole Sullivan family swooped down from the uplands and settled on the Little River, and then it was thought there wer enough people to perfect an organization of the county, and in January, 1870, a census was taken and it was found there were six hundred and seven souls in the county, and the people still kept coming.

About this time Griffenstein bought out Durfee and took charge of the ranche, and also got hold of the claim lying south of Waterman's, now know as Griffenstein's addition. Wichita began to loom up as a point. There was a general understanding among the people that it was going to be the biggest town yet.

The proper papers for the organization of the county were sent to Topeka and in due time the proper documents arrived for that purpose. S. C. Johnson, Wm. Lockard and Henry Stein were appointed Commissioners to organize the county. They all survived the shock and still live. John Ward was appointed County Clerk. The Commissioners divided the county into three voting precincts, on lines equi-distant running east and west through the county, and called an election for county officers and to locate the county seat, to be held on the April. A convention was called and nominated a ticket, and there were several independent candidates. The county seat question cut a vigorous figure in the campaign. The following officers were elected: N. A. English, T. S. Floyd and Alex McWilliams, County Commissioners; J. M. Steele, County Clerk; F. J. Fulton, County Attorney; L. F. Buttles, Register of Deeds; D. A. Bright, Clerk District Court; Reuben Riggs, Probate Judge; W. N. Walker, Sheriff; S. C. Johnson, Treasurer; John Price Hilton, Superintendent of Schools; Wm. Finn, Surveyor; E. B. Allen, Coroner. The total vote was two hundred and sixty. Wichita scooped the platter for county seat over Park City. J. M. Steele and H. E. Vantrees were chosen Justices of the Peace; Wm. Smith, Trustee; and I. S. Elder, Constable of Wichita township.

The court house used by the county on its first organization was a unique structure, built on a plan supposed to be after Solomon's own heart, devised by the same architect that evolved the plan of the Buckhorn hotel. The inside finish was nice but not gaudy—just like the outside. The vestibule was occupied by Jack Peyton as a saddle and harness manufactory, the rotunda was occupied by Dutch Tobe as a boot and shoe manufactory, an ante-chamber adjoining the rotunda was occupied by the Probate Court. The County Attorney also had his library there. The east wing was devoted to the occupancy of the several county offices, and the vaults for the safe keeping of the county records. It also contained a club-room and a complete outfit consisting of a cooking stove and frying pan. It also contained a justice's court room. All the lawyers, real estate agents, surveyors and notaries public in the town had their offices there, but the ruthless hand of time has laid waste its walls.

The first official act performed by any duly elected, qualified and acting officer was the ceremony of uniting in marriage Miss Anna Peck to a Mr. E. J. Marsh, of Indianapolis, Indiana. This serene duty was performed by Squire Steele on the 14th day of May, 1870. The ceremony took place in the open air, beneath the sylvan shade of spreading cottonwoods on the banks of the Little Arkansas, near the residence of the bride's father. A large and joyous party of friends assembled to witness the beautiful rite; an elegant repast was served upon the green sward. The youthful Squire was on hand at an early hour, happy with the rest; but as the solemn moment came on he felt a strange distrust as to his ability to speak his piece, so he slyly slipped away from the merry crowd and sped behind a large bare log that lay along the bank; he placed the copy on the ground and reclining up elbows and knees, with face in his hands, he repeated o'er and o'er, the story to be told, until sure that every line and letter was imprinted in his mind; then mingled again with the crowd. The couple joined right hands and with flushed and rosy cheek, the Squire spoke the solemn words so nicely and so well that when it was done he scarcely knew whether he or the groom were receiving the happy congratulations.

On the 24th day of March, 1870, D. S. Munger filed a plat of the southeast quarter of section seventeen in

township twenty-seven, range one, east, and on the same day William Griffensten filed a plat of the ast half of the northeast quarter of section twenty, and by the mutual agreement of the two proprietors the two plats constituted the town site of the town of Wichita. At that time the town in fact was located on the banks of the Little River, on what is now North Waco street. But Griffensteen put up a store building on his part of the site and moved his goods into it, then Schweiter, Hilton, Waterman and Oatley followed and built near him, and Griffenstein began the erection of a hotel building, now the L part of the Empire House—in its day and generation the finest hotel west of Emporia. Then the driving season opened, and there was a general movement of business houses on to Main street. About that time the firm of Geo. Smith & co., opened out the first wholesale grocery house. The business was under the management of a man who cut no little figure in his day and his name was Ed. W. Smith. To all intents and purposes he was "the nicest fellow you ever saw." He sold an immense amount of goods and it was thought he was piling up wealth in chunks. Being exceedingly popular he was easily induced to run for the Legislature, which was the fattest take for a large number of able-bodied voters they had ever had, for it gave them credit at his store, and it brought him into a close acquaintance with numerous gentlemen that had a taste for Robert Schenck's favorite game. But Edward not being a Kansas politician got laid out high and dry, and finding himself somewhat backward in his accounts with his employers, he went on a visit.

The first meeting of the County Commissioners was held the 27th of April. The first official act wa the granting of a dram-shop license. The first county order issued was in favor of T. S. Floyd.

During the month of April, Wichita received a large increase to its business population. Dr. E. B. Allen came in, took a claim, and began practicing his profession, and was the first physician here. On the 15th of May the first drug store was opened. This was by J. P. Allen who is still in the business, and his City Drug Store enjoys the proud distinction of being the oldest business house in the valley, and it is a fact worthy of note, that it is the only business of any kind established in 1870 that has kept on in the even tenor of its way and still survives.

About the same time the first millinery store was established which, the following winter, succumbed to the tidal wave of hard times. Not the least of the institutions that came along about that time, was the inevitable "circuit rider." The Rev. W. H. Zellers was appointed to the Wichita circuit that spring. He was full of the spirit of his Master and worked faithfully to get the seed of the Kingdom to take root here, but the generality of the people, in their own practical way, mistook him for a Pawnee Indian and hearkened not to his voice. So Zellers took a claim, and as soon as he got it proved up, he packed up his things and went "back to his folks."

About the first of May D. S. Munger was appointed postmaster in place of Kellogg, and the office was moved into his hotel. Munger was a model postmaster. He knew the name and face of every patron of his office and the quarter section he lived on and just when he took it. But the host of emigrants that poured into the country that summer was too much for the old man, he couldn't remember them all, so he resigned. It is safe to assert that no postmaster ever handled as much mail matter for one dollar a month as did Munger.

On the first day of June a census was taken by J. M. Steele which showed a population of 1,000 people, but included everybody from Fort Harker to the Nation.

The first term of the District Court began on the 13th day of June. It was held in the attic of a livery stable, nearly opposite the Empire House, Hon. W. R. Brown, of the 9th, which included Sedgwick county, was the Judge. The other officers present were W. N. Walker, Sheriff, F. J. Fulton, County Attorney, and C. S. Roe, Deputy Clerk. The attorneys of the Wichita bar present, besides Fulton, were Reuben Riggs, P. T. Weeks and H. C. Sluss. The attorneys from a distance present, were E. C. Hackett, Esq., of Emporia, and W. P. Campbell of Eldorado. The court room was provided with one chair which was occupied by his honor the Judge. The table for the accommodation of the lawyers consisted of two good boxes set "end for end." The seats for the bar consisted of a two by six cottonwood scantling resting at each end on cracker boxes, and placed at a convenient distance from te talbe, and along which ranged the lawyers. Behind the boxes sat the Judge in his solitary chair with his right heel resting gracefully over his left knee, his right elbow resting upon the arm of his chair, and his chin firmly planted in his right hand, and his left hand in his pants pocket. The seats for the bystanders consisted of the same material and pattern as that for the bar, and ranged around the wall. The trial docket consisted of a single sheet of foolscap paper, and the bar docket and the journal of the same. The cases at issue were three; one a murder case, one a State case against the aforesaid Alexander Jester, charged with an assault with intent to kill, and the other a divorce case. The divorce case was tried, witnesses examined and a decree for the plaintiff, which was the husband. It was developed on the trial, that the defendant in her playful mood, had kicked the plaintiff out of bed and compelled him to sleep on the floor, and as they lived in a dug out, this was adjudged a sufficient "ground" to justify a divorce. The case of murder was taken, by change of venue, to Butler county. In the assault cause the defendant interposed a motion to "squash" the information, which was done. It is a curious fact that no record of the proceedings of that court was made, and not even the scratch of a pen remains to tell the fact of the granting of that divorce.

On the 3d day of July the first child was born-unto Joseph and Mary Allen. In honor of the event Griffenstein donated a town lot to the child, but the little one survived but a few weeks, and was laid away upon the lot.

On the 4th of July all the people came together to celebrate the day, and brought their dinner along. A buffalo was brought in and roasied whole, but when it was cooked, it was discovered that time and the hot weather had slightly tarnished the taste and it was heaved into the river. The celebration was held in Waterman's Grove; Reuben Riggs was President of the day, and Wm. S. Jay, of Emporia, was orator, and of a truth, he talked the people blind. A magnificent dinner was served and there were plenty for all, after which dancing and a good time generally was indulged in, and taken altogether it was the best and most enjoyable celebration of the kind ever held in Wichita. At night the new hotel was dedicated with a grand ball, which for cram and jam, sweat and smother did beat all.

On the 30th of May, E. P. Waterman laid off an addition to the town on the west, and the following August, J. R. Mead platted his addition on the east. The town, however, was mainly confined to Main street, most of the business men who had families lived either in the back room or the attic of their stores. But it was manifest that this was to be a city which could not be hid. Brick kilns were burned, the foundation of a grand brick hotel was laid, and so far as is known still lies there. The spirit of enterprise seized the people. The Arkansas Valley Gas Company was organized with Little Smith as manager. A bridge company was organized which had for its object the building of a bridge across the Arkansas, with somebody else to furnish the money. Railroad companies, too numerous too mention, were organized. D. C. Hackett was put astride a pony and sent t90 Junction City to bring a railroad down. J. H. Dagner afterward became chief engineer of that road and made an accurate survey and plat of it, and demonstrated the fact that the road would be built with a very slight expenditure of money. A number of town lots were also deeded to Hackett to send him to Texas for the purpose of procuring the Texas Legislature to join in with Wichita in the construction of a grand southern route from Wichita to the Gulf. It may be remarked that Hackett had a soft thing. But winter came on apace and nipped all these blossoms in the bud.

On the 25th day of September an election was held for the purpose of voting \$200,000 in bonds to the railroad company that should first build a road to Wichita. The bonds were voted by a handsome majority, but owing to the obtuse intellects of the railway magnates the offer was not accepted.

A. G. Burr & Co. brought in a saw mill during the summer and "let the machine go," near the mouth of the Gypsum, on the Gifford farm. The mill was afterward moved down to old Fort Yanko and did a prosperous business. Another inevitable visitation received about that time was Richard Robinson, Esq., the "fust cullud pusson" in the valley. And about the same time an invention was introduced in this valley known as the "real estate mortgage," which proved to be of great convenience to many of the people, and was used to ornament a majority of the farms in the county.

In July, Wichita, by an order of Reuben Riggs, Probate Judge, was duly incorporated as a town, and the following board of trustees was chosen: C. A., Stafford, Chris. T. Pearce, Ed. W. Smith, John Peyton and Morgon Cox. C. A. Stafford was elected chairman, Ed. Smith, Treasurer of the board, G. H. Smith was appointed clerk, H. E. Vantrees police magistrate and Ike Walker marshal. Laws and ordinances at once began to pass themselves, but from a lack of ballast failed to enforce themselves. Valuation of taxable property for 1870, \$74,279; total amount of county orders issued, \$1,618; total tax collected for the year, \$1,718.

On the 18th day of August, 1870, the Wichita Vidette unfurled its banner to the breeze. It was a bright, handsome, witty, newsy newspaper, and in its day was the organ of the Southwest. Editorially it was a success, but financially its pathway was not strewn with the sheaves of plenty heaped up in heaps, so to speak. It may be siad that the Vidette also succumbed to the biting frosts of a wintry mortgage.

The season was fine and dry until September, when it began to rain and rained continuously, on which account the Whitewater became an important element in the prosperity of Wichita. It was no uncommon thing for freighters to be detained a week upon its banks. In October, Sol. Kohn came in with the big dry goods store.

In October, a regular Republican convention was held, which nominated the following ticket: Commissioners–T. S. Floyd, C. H. Stone and McWilliams; Representative–J. M. Steele; County Clerk–J. W. Ransom; Sheriff–W. N. Walker; Treasurer–S. C. Johnson; County Attorney–H. C. Sluss; Probate Judge–Wm. Baldwin; Register of Deeds–F. A. Sowers; Surveyor–T. H. Dunlap; Coroner–E. B. Allen.

Shortly afterward there was a people's convention held which put the following gentlemen forward: Commissioners–N. A. English and T. S. Floyd; Representative–Ed. W. Smith; Sheriff–J. E. Ledford; County Clerk–H. L. Brown; Register of Deeds–Geo. E. Clerk; Treasurer–E. P. Waterman; Probate Judge–Reuben Riggs; Surveyor–John A. Sroufe.

Wm. Smith ran as an independent candidate for sheriff, as also H. E. Vantrees for register of deeds. With the exception of sheriff and one county commissioner, the entire Republican ticket was elected.

The winter of '70 was uneventful except for the animated presence of hard times. During the year about one hundred houses were built and nearly every one was dedicated with a grand ball, and during that winter the "ball" kept rolling. In November Hilton's addition was platted and laid out, and in December English laid out his addition.

On the 18th March, '71, the first conflagration took place. The stock of boots, shoes and queensware of W. P. Rouse, and the saddle and harness stock of John Peyton, was entirely destroyed; loss about \$5,000.

In February, J. E. Ledford was killed by Jack Bridges and Lee Stuart in attempting to arrest them under a

United States warrant.

In April, Wichita was organized as a city of the third class, and the following officers were chosen: E. B. Allen, Mayor; W. B. Hutchinson, S. C. Johnson, Geo. Shlichter and A. H. Fabrique, Aldermen; D. C. Hackett, was appointed City Attorney; Mike Meagher, City Marshal, and O. W. Bromwell, City Clerk. About this time W. C. woodman opened the First Arkansas Valley store.

In June, the Wichita & Southern Railroad Company was organized with the following officers and directors; J. R. Mead, President: Wm. Griffenstein, Treasurer; H. C. Sluss, Secretary; Sol. H. Kohn, J. M. Steele, S. C. Johnson, G. H. Smith, Geo. Shlichter, C. F. Gilbert, T. J. Peter, R. W. P. Muse, F. J. Fulton, Directors.

On the 11th day of August an election was held to vote \$200,000 bonds of the county to aid in the construction of the W. & S. W. R. R. to Wichita. The chief opponent of the measure was Park City. The contract for building the road was let at once, and the work soon began. During the year Main Street was built up nearly solid from Second street to Douglas avenue. In the fall the Empire House was built by E. J. Blood. It was dedicated in the usual way.

On the 7th day of August the Wichita bank opened out for business with J. C. Fraker at the helm. This was the first banking institution, and was later in the fall reorganized into the First National Bank. The valuation of taxable property for 1871 was \$481.731.23. Total county orders issued, \$15,313.00.

In the spring of 1872 Wichita was organized as a city of the second class. In April the U. S. Land Office was moved from Augusta to Wichita. About the first of June the railroad was completed to the city, from which time the old Wichita passed away and all things became new.

ATCHISON, TOPEKA & SANTA FE RAILROD.

Very few people, comparatively, are aware of the length and character of the Santa Fe Route. R., which gives a connection with tide water at Galveston, Texas. From Emporia the course of the road is almost due west, following the beautiful Cottonwood valley to Newton, then southwest to Wichita, passing through a region which has been aptly called "the garden of Kansas," a large portion of which is similar in almost every characteristic to the famous "Blue Grass Region of Kentucky."—Commonwealth.

KENDLE & GRAHAM






